**AGREEMENT BETWEEN
K.D. National Force Security and Investigations Agency, LLC
and
THE DENNIS TOWNSHIP SCHOOL DISTRICT
BOARD OF EDUCATION

CONTRACT FOR SECURITY SERVICES
2019-2020 School Year**

This is an Agreement for school security services, entered into as of July 1, 2019, by and between the Dennis Township School District (the "District") located at 610 Hagan Road, Cape May Court House, New Jersey 08210 and the K.D. National Force Security and Investigations Agency, LLC ("the Company") located at 3122 Fire Road Suite B210 Egg Harbor Township, New Jersey 08234.

WHEREAS, the District advertised and received bids for school security services; and

WHEREAS, the contract for school security services was awarded to the Company;

NOW THEREFORE the District and Company agree to the following terms and conditions.

1. The term of this Agreement shall commence on the date the Agreement is fully signed by the District and the Company and shall expire on June 30, 2020, unless terminated sooner.
2. The Company agrees to provide school security services to the District and agrees to comply with the requirements contained in the Bid Specifications and General Requirements and Technical Specifications (Bid No: SSS-RFP 18-0725) (altogether referred to as "Specifications") which are incorporated herein as if fully set forth in their entirety. The Specifications include, among other things, a description of the scope of services to be provided (pp. 24-25), standard requirements for school security services (p. 25), qualifications for school security specialist (p.25), and requirements pertaining to insurance and indemnification (pp. 15-20).
3. The requirements pertaining to indemnification shall survive the termination of this Agreement.
4. The District may terminate this Agreement in accordance with the termination provision in the Specifications (p. 22).

5. During the term of this Agreement the Company will: (a) comply with all local, state or federal laws related to provision of school security services; (b) comply with all applicable local, state or federal laws prohibiting illegal discrimination; (c) maintain in good standing all licenses, registrations or certifications applicable to provision of school security services, including but not limited to those referenced in the Specifications; and (d) maintain in full effect all insurance coverages required by the Specifications.

6. The word day for security officer/specialist is 8.0 hours per day. The cost of security services provided under this Agreement shall be as follows:

The cost per armed security officer/specialist is \$51,912.00 per school year (assumes 180-day school year and 8.0-hour work day and five day work week). The per diem rate for purposes of proration is \$288.40. Any hours accrued beyond the scheduled 8.0-hour work day is \$36.05 per hour.

The cost per armed security officer/specialist inclusive of all costs beyond the 8-hour day for evening, weekends, school/district events and sporting events is \$36.05 per hour. A minimum 3 hours per armed security officer/specialist is required for the sporting and extra-curricular events.

7. The Company will invoice the District on a monthly basis for security services rendered under this Agreement. The invoice will identify the name of the security officer/specialist, the dates worked during the month and the cost per day. The District will remit payment within 30 days of receipt of the invoice.

8. No amendment, modification, or waiver of any provision of this Agreement shall be binding unless signed by both parties.

9. This Agreement shall be governed by the laws of the State of New Jersey. Any action pertaining to this Agreement shall be brought in the Superior Court of New Jersey, Salem County.

10. No party to this Agreement shall assign his rights or duties hereunder without the prior written consent of the other parties.

11. This Agreement is made for the sole benefit of the parties. No other persons shall have any rights or remedies by reason of this Agreement against any of the parties or shall be considered to be third party beneficiaries of this Agreement in any way.
