3.	PARENT agrees to pay the tuition for	or <b>STUDENT</b> of	\$3,700.00, or \$4,200.00 should the		
	STUDENT require BSI (Basic Skills Instruction) in one (1) of the following methods				

designated by placing a check mark by the specific choice of payment and initialing to the left of the check mark or attaching separate addendum of agreement for payment as agreed upon with **BOARD**.

- A. \_\_\_\_\_Payment in full on or before **STUDENT** entering the School District at the beginning of the school year, September 1, 2022 (10% discount)

  B. \_\_\_\_Quarterly payments in accordance with the following Schedule:

  August 31, 2022 \$925.00/\$1050.00

  December 1, 2022 \$925.00/\$1050.00

  March 1, 2023 \$925.00/\$1050.00

  May 2, 2023 \$925.00/\$1050.00
- C. \_\_\_Monthly payments of \$370.00/420.00 for each full or partial month the student resides outside the District, payable on the first of the month.
- D. Other payments as agreed upon by **BOARD**.
- 4. Should the monthly payment or quarterly payment not be received by the 10<sup>th</sup> day of the month, on the 11<sup>th</sup> day, an automatic 10% late fee will be added to the amount owed for the month. If the monthly payment and late fee are not paid by the 30<sup>th</sup> of the month the student will be removed from the program.
- 5. Transportation for **STUDENT**, to and from school, shall be the responsibility of the **PARENT**.
- 6. If, however, **STUDENT** herein, either upon entry at the beginning of a school year or if determined during a school year, shall require special education pupil costs as computed by the School District of Dennis Township, that cost shall be borne by the **PARENT** herein. **PARENT** agrees that and acknowledges that the special education pupil cost may be in effect upon the **STUDENT** entering the school year, at which time he/she may be classified as requiring special education pupil costs or the **STUDENT** may enter the School District paying the Student Tuition in one amount and upon the school's determination that the **STUDENT** is classified as "a student requiring special education pupil costs", **PARENT** agrees to pay the additional amounts as computed by the School District.
- 7. **PARENT/STUDENT** will abide by the requirements for a **STUDENT** paying tuition.
- 8. **PARENT** agrees that if **PARENT** should be in default of the responsibility of payment of tuition or if **PARENT/STUDENT** shall be in default of any other responsibilities required by the Rules, Policy, and Bylaws of the Board of Education of Dennis Township, then **STUDENT** may be required to withdraw from the Dennis Township School District in accordance with all appropriate Statutes and Regulations.
- 9. **PARENT** agrees that good behavior must be maintained, and it is at the discretion of the Superintendent to sever the agreement based upon the **STUDENT** behavior.

- 10. This Agreement shall not be altered, modified, amended or abridged in any way, except by a writing signed by the parties hereto.
- 11. This Agreement shall be governed by and construed in accordance with the Laws of the State of New Jersey.
- 12. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto, their respective heirs, personal representatives, successors and assigns.
- 13. Nothing contained herein shall constitute an admission by any of the parties. This Agreement shall not be evidential in any proceedings between the parties except if such proceedings should relate to enforcement of this Agreement itself.
- 14. This Agreement constitutes the entire Agreement between the parties hereto with respect to the subject matter hereof.
